REACH Statement

The Registration, Evaluation, Authorization and Restriction of Chemicals (REACH) regulation (EC) No 1907/2006 is a chemicals legislation applicable in all EU Member States as well as the three EEA EFTA (European Economic Area / European Free Trade Association) States of Norway, Liechtenstein and Iceland.

Lumentum is affected by the REACH regulation as a supplier of articles and understands the obligation for communication of substances included in the Candidate List of Substances of Very High Concern (SVHC) in articles in accordance with Article 33 of the REACH Regulation.

Lumentum consistently monitors any new substance entries into the Candidate List published by the European Chemical Agency, and reviews if the substances are included in Lumentum products.

To the best of Lumentum's knowledge, based on information provided by its suppliers, some of Lumentum's products may contain the following substances from the [Candidate List of SVHC](#) in the concentration above 0.1 % weight by weight in an article:
